RULES

NO PURCHASE NECESSARY. The **GAS SOUTH DISTRICT 2022 Classroom VIP Sweepstakes** (“SWEEPSTAKES”) is open to entrants who are a U.S. Citizen and at least thirteen (13) years of age.
